

Speaking with the **Daily** Revelation yesterday, Kabimba said he was shocked by former president Edgar Lungu's hypocrisy and complaints against thuggery, saying he would not be complaining today if he had done his part when he was privileged to serve the country as head of state.

He said while Zambians were complaining about the terror the PF cadres had unleashed, Lungu found it normal to have lunch with the likes of Innocent Kalimanshi and others.

"Edgar issued a statement the day before yesterday where he was saying to HH 'can you stop this thuggery', and he referred to it as nonsense. Now my view is this, firstly all of us as citizens have a duty to contribute to the construction of a just society and an orderly society," Kabimba said. "Now if Edgar had done the right thing, he will not be crying today. If he had made sure that there was no thuggery, there was no political violence, there was respect between and amongst citizens, that there was no corruption, he would not be crying today because he would have contributed to the construction of a just society."

Kabimba said Lungu's successor, President Hakainde Hichilema, would have struggled to destroy the kind of culture that would have been created from a just society. He said today, Lungu would be facing a judiciary in which he had a lot of confidence, that if he or those he loved where innocent, they would be declared so by the courts of law

Kabimba decried that

judiciary and won complete confidence of the people. So for him to turn round now and tell HH that stop the nonsense, the nonsense which he himself didn't stop, and he says it's no longer a viable argument that because this happened under PF therefore you must continue with it. When you are constructing a society, you are constructing a society for now and the future."


Kabimba also said the same Cabinet of Sata which had Lungu as Home Affairs minister resolved on several important matters in the interest of Zambians, but Lungu did the exact opposite when he assumed office.

He said Cabinet resolved against refunding LAP Green on the amount of money they claimed to have lost out on when the PF government repossessed Zamtel owing to the fact that they had no argument as the transaction was not straight forward.

He said the same arrangement was reached over the Kasumbalesa concession given to foreign investors.

"Michael Sata dies, I leave PF, the same guys that were part of that decision they reverse the decision and pay these people. You remember the removal of RB (late former president Rupiah Banda's) immunity, again we agreed. It was the resolution of Cabinet that we thought that we had evidence against RB over corruption," Kabimba said, adding that on the basis of the same, he took the motion to Parliament to remove Banda's immunity.

Kabimba, however, said the same PF leaders who had voted overwhelmingly for the lifting of the immunity, reneged on their own decision and entered a consent judgment with Banda the moment Sata died. "And today you can turn round and say that stop the nonsense! The nonsense which you yourself cultivated and failed to stop," Kabimba said. "I mean this level of hypocrisy really shocks me. And it's interesting how Zambians can have a short memory, you know, a short, short memory within two and half years. It's very shocking." Asked as to why he campaingned for Lungu's re-election in 2021 having

Kabimba said he also told Lungu that he had a divided Catholic Church, part of which was for him and another part against him, although it was not known which group was larger than the other.

Kabimba said he told Lungu that systemic corruption, perceived or otherwise, stood against him too.

I said there is indiscipline in your party," Kabimba said. "I said deal with these things otherwise you have a difficult election ahead of you. And Hamasaka said Lungu was misdirected for challenging President Hichilema to tell him what he had stolen.

"Have you ever heard HH commenting about Edgar Lungu anywhere? These are questions for ACC, DEC where he is appearing. That is not HH," Hamasaka said. "He should direct these questions to the Law Enforcement Agencies. Otherwise directing them to the President is completely misdirected."

Asked about the unruliness of UPND cadres who were seen insulting Lungu when he accompanied his family members at DEC offices last week, Hamasaka said these were issues which were being addressed internally.

He said such incidences occured once in a while.

"I am sure even you agree with me that these are incidences that once in a while turn to re-occur. Otherwise they have been dealt with quite severally. This is not the country you knew in the past. There will, once in a while, recurre old habits which were being dealt with," Hamasaka said. "I am sure if you ask bena (UPND national youth more."

During an interview with the Voice of America on Sunday, Lungu complained that he had been called a thief, corrupt and all sorts of names but no one had told him what he stole or wherein lied the corruption.

He said he had asked people that if they found any corruption, they should take it forth but that no one had done so.

"They decided to peel my family like an onion reaping all peels and trying to get at me instead of coming for me," Lungu said. "You see, my wife was unemployed and she was depending on me and I was supporting her like every other person supports the wife, you support your children and if you support them, then they utilise that money for some purposes. They even tell the Law Enforcement Agencies that guy is the one who provided the resources. Why can't you go for him and ask him how much your salary was and how did you acquire this property."

Lungu said he was a lawyer before he became a politician and he was one of the top notch lawyers.

And the State yesterday dropped the charge of espionage against Changala.

Changala told Daily Revelation that when his matter came up on Monday morning for Constitutional bail hearing in the High Court, the state was not ready to proceed and applied for an adjournment to afternoon. When the parties convened in the afternoon, the state applied for another adjournment on the premise that they were not ready but the judge declined to grant the application. Changala said the State was told that they should have waited until they were ready to effect an arrest. He said the judge asked the lawyer for the prosecution about what President Hakainde Hichilema had been saying regarding arrests.

"He said the President said investigate, arrest and give police bond if the law allows. Now Mr. Changala has been in custody for seven days and you came to my court to say you are not ready? No! Do you know what I am going to do? I am going to give Mr Changala unconditional bail," the judge said. " Do you know what that means, no sureties, no other incumberences Mr Changala is granted bail here and now in his own name and he is free to go to his house." He said the judge reiterated his counsel to the state that the President was on firm ground that matters should be investigated, then effect an arrest and charge the person within 48 hours and arraign the suspect before the court of law. Changala added that based on the above, the

judge denied the State an adjournment and said he was free to go home and be with his family.

" On this one the adjournment is denied. Mr Changala is free to go home and be with the family. He will attend court as and

Lungu scrapped off the legal and justice reforms he and late president Michael Sata set up, which was intended to transform the judiciary, the police and the prison services, as these institutions were inter-related in functions.

"If Edgar's PF had allowed that commission to go ahead, we would have a police service today which respects civil liberties of citizens ... People would not be sent to prison and find that they are living in squalor," Kabimba said. "The judiciary would have become the people's

when you need him. You will be getting in touch with him," Changala narrated.

And when he appeared in court yesterday before Chief Resident Magistrate Davies Chibwili, Changala pleaded not guilty to the charge of sedition.

Earlier, Changala was charged with seditious practices and espionage but when he appeared in court the only offence appearing on the charge sheet was sedition.

Magistrate Chibwili has since adjourned the case to July 16 for commencement of trial.


friends.

Zambia's High Commissioner to Malawi Colonel Panji Kaunda told *Daily Revelation* yesterday that his brother died in the University Teaching Hospital last Monday following a long

One of the family members said Dr Waza was being treated in the UTH intensive care unit, over some illnesses, including battling with diabetes for a long time.

Col Panji said the funeral house was in Jesmondine, Lusaka, and that the Church service for the late Dr Waza will be held at St Ignatius Catholic Church in Rhodespark area tomorrow, with burial to follow at the same site where his late mother, Mama Betty Kaunda, at the family's State Lodge residence.

"The funeral is being handled by the family but everybody is welcome to help," said Col Panji, adding that the late Dr Waza is survived by a wife and five children.

And Imboela has accused the UPND and police of doing everything possible to kill the abduction case involving Petauke member of Parliament Emmanuel Jay Jay Banda.

Speaking to Daily Revelation, Imboela accused Ngoma of defaming her, saying it was clear that the move taken was meant to pre-empty her and stop her case against him.

"Personally, I am suing Levy. He wrote in the Diggers when I said if Jay

Imboela explained that at first, the police were also denying his lawyers to see him.

"Finally when the lawyers saw him, the man named his abductors. He named them and some of us shared the stories which were written. First of all, I shared a presser by his lawyer Sakwina Sikota State Counsel, I shared it on the page, I also shared what Zambia Whistleblower wrote, I also shared what president Sean Tembo shared. It stated ' justice for Jay Jay Banda' that his abductors should be brought to justice. I shared that," Imboela said.

was wrong in the article, then the aggrieved should go for the source saying that was why articles were cited.

"For them to name me, they are very desperate and I know that they have been after me," she said. "They are too desperate and they had to find anything for me to go in."

Imboela said she was not scared of the move taken by Ngoma and Mwiinde as she was used to their machinations and schemes. She accused the UPND

of thriving on lies and propaganda.

Imboela said she has not even shared her views yet she was being reported to the police.

She said people should not rush to take others to the police before investigations are concluded.

"They need to wait for investigations. For the matter to have a mature conclusion. As investigations are going on, we shall not stop concluding and asking questions. I have not even given any opinion just to see my name on a document," said Imboela.

Last Monday, Ngoma and Mwiinde filed a complaint with the police after they were linked to the recent abduction of Banda. Those cited include

through media reports, that Ngoma on Monday filed a complaint with Zambia Police against him for criminal defamation, in relation to the statement which he issued on June 02. 2024 calling on the police to arrest the individuals who had been named as being involved in the abduction of Banda as revealed by his lawyer Sikota.

He stated that section 193(1) of the Penal Code Act, Cap 87 of the Laws of Zambia defined criminal defamation as "... publishing a false statement against another person ...".

Tembo stated that it must be noted that the statement which he issued was neither false nor untrue nor defamatory because it was a fact that Banda' lawyer had publicly stated on numerous occasions that his client fingered Ngoma and two others as being involved in his abduction, when the police allegedly interrogated him in the presence of his lawyer.

"In the premises above, we wish to reaffirm that as Patriots for Economic Progress, we stand by our statement which we issued on 2nd June 2024 and further state that there is nothing false, untrue or defamatory about our statement. We also

wish to re-echo our demands alleged abductors being Mr. Levy Ngoma, Mr. Clayson Hamasaka and Mr. Trevor Mwiinde and subject them to an identification parade so that the abduction victim; Hon. Emmanuel "Jay Jay" Banda can formally identify them. A victim's testimony in an abduction case is the strongest form of evidence that can ever be adduced," he stated.

Tembo said as Patriots for Economic Progress, they had further noted, from the media, the demand of K5 million from Ngoma's lawyers for alleged defamation against their client.

"We wish to categorically state that Mr. Levy Ngoma is not entitled to any such compensation, as he was never defamed. We look forward to meeting Mr. Levy Ngoma and his lawyers in court, where we shall vigorously challenge their frivolous claim," stated Tembo."Lastly, we wish to state that, should the Zambia Police follow through with Mr. Levy Ngoma's frivolous complaint for criminal defamation against us, as they have done in previous cases involving opposition leaders, we stand ready to be arrested. Let the Zambian people be the judge."

Mwanza further said the UPND are smooth "criminals" who are

stealing money through maize

import and export. "Why were they hell bent on exporting all our maize? Because they were the ones who were eating, and they are very smart sibaja ba kawalala ba K2, aba ni ma smooth criminals ba pa level inangu (they are not thieves who steal small amounts like K2 but they are smooth criminals who are on another level). So they use legislation, they use government legislation to steal, when they were exporting the maize, they removed export duties," he said. Mwanza further said despite the difficulties the country was going through currently, the President was quiet and just playing politics with his opponents. "Who would have thought that the President Hakainde Sammy Hichilema will one day stand and say that when you throw punches at me, l will retaliate by going for your neck? Who would have thought those words would come from the President? People don't have mealie-meal, loadshedding but he is quiet," said Mwanza.

Bowman Lusambo has insisted that he bought the Hungry Lion food packs and saw the police officers eat.

But the police have refuted claims of Lusambo buying food for their officers.

Speaking to *Daily Revelation*, Lusamba explained that when he and his team went to Hungry Lion, police officers started following them.

"After that, I told my guys that we go and have some snack pa Hungry Lion. So, what happened was that those people were following me, about six vehicles

Lusambo explained.

He said when the police officers saw that he parked at Hungry Lion, they also parked near Debonairs.

Lusambo said when he saw this, and realising that he was in court for some time, he knew that the officers needed something to eat.

He said it was not only patrolling officers who were given food packs, but he also gave officers who were at the courts.

"We gave OP guys who were at the courts to buy food. When we saw those guys at Hungry Lion, I told

bottles of water. We gave them," he said. "At first we sent one of our guys to ask them if they wanted to eat so we buy food for them, and their commanders accepted they were two. They said let them buy food for us. There is no problem and we bought."

Asked about the police statement refuting his kind gesture, Lusambo said Hamoonga was lying and should learn to keep quiet.

"I have seen my brother Rae Hamoonga trying to twist the story and I was laughing. I said who do they want to change the narrative news, no! I gave them because they needed food okay," Lusambo said.

He also said the police had been using the officers without giving them anything to eat.

Lusambo said he is a member of the Zambian government by virtue of him having served in the government as Lusaka Province and Copperbelt minister.

He said he is in the system, and he knows that those police officers had been complaining that they were not being looked after.

# Copper falls below \$10,000 per tonne -Mining.Com

opper prices fell below \$10,000 ✓ a metric ton as traders weighed a sharp rise in global inventories and soft US job openings data that reinforced bets that the Federal Reserve will be able to cut interest rates this year.

Stockpiles on the Shanghai Futures Exchange have climbed to the highest since 2020, and there have also been a steady stream of smaller inflows into

Asian depots tracked by the London Metal Exchange over the past few weeks. Inventories typically decline at this time of year, and the jump has put pressure on prices after copper spiked to a record high above \$11,100 last month

Base metals have surged this year on hopes for lower US interest rates and signs that China's economy may finally be emerging from its post-pandemic slump. Meanwhile, the ongoing rise in exchange inventories offers

evidence that buyers are amply supplied for now and serve as a headwind for bulls predicting that prices will soon make another push higher.

"The copper market seems much more sufficiently supplied than some traders had hoped for," Carsten Menke, head of next-generation research at Julius Baer, said in an emailed note. "Hence a rapid turnaround of copper prices thus looks unlikely in our view and we rather expect the market to consolidate during the summer months."

Copper fell 1.7% to \$9,968.50 a ton on the London Metal Exchange as of 3:26 p.m. local time. The metal racked up a third monthly advance in May after hitting a record during the month. Shares of copper miners also tumbled, with Freeport-McMoRan Inc. down as much as 4.8%.

Other main base metals fell on the LME except aluminum, which edged higher.

But Dr Mubanga said the move has been taken in order to silence him, saying they have since made a part payment of K200,000 which should move the board to lift the suspension as part payments are guaranteed by law.

According to the judgment in default delivered by the High Court availed to Daily Revelation, ERB won the case to recover K620,444 from Exxon Petroleum.

"The defendant not having appeared and filled a Defence to the writ of summons herein and the time in which to file the same having lapsed following due service of the court process herein. IT IS THIS SAY ADJUDGED that the Plaintiff recover against the Defendant actions in managing his company's business were improper and fraudulent

"Consequently, it is just and appropriate to hold the 3rd Defendant, who was evidently accountable for the daily operations of the 1st Defendant's business, liable for the debt owed to the Plaintiff ... Consequently, I hereby Order that the 1st Defendant's corporate veil be pierced and hold the 3rd Respondent personally liable for the Judgment debt herein," judge Maka ruled. "Costs of this application are for the Plaintiff, to bet axed in default of agreement. 9.4. Leave to appeal is hereby granted."

Luapula Energy in June 2021, sought relief in form of K3,506,195.90 being the amount due and majority shareholder and managing director, expressed interest in purchasing 110,000 liters of diesel and 400,000 liters petrol from the plaintiff totaling K7,383,000, and that at the request of Exxon, the plaintiff prepared and issued a pro forma invoice on February 24, 2021.

The invoice specified that 50% of the purchase price was to be paid before delivery, with the remaining amount to be settled upon delivery of the petroleum.

Luapula Energy argued that Dr Mubanga accepted the terms and provided the plaintiff with a letter instructing Ecobank Zambia to transfer 50 percent of the purchase price totaling K3.5 to the plaintiff's account, upon which 14 trucks of petroleum products were

Energy informed the Plaintiff that they had already paid the 1st Defendant for the supplies. On March 23, 2021, the Plaintiff, through its legal representatives, sent a demand letter for the outstanding amount of ZMW4,908,879.30. The 3rd Defendant, representing the 1st Defendant, pledged to settle this sum by March 26, 2021."

But Dr Mubanga only made a partial payment of K1,402,683 and leaving a balance of K3,506,195.90, prompting Luapula Energy to initiate the main court action, resulting in the delivery of a judgment in default of defense on May 12, 2022

But Luapula Energy indicated that enforcing the default judgment was not feasible due to the absence of a known trading location for Exxon, saying despite PACRA record indicating that the defendant's registered address as Shoprite Building, Cairo Road, Chipata, no trading location could be located as the search conducted at the registered office revealed that Exxon was not located there. The situation moved Luapula Energy to seek an order to pierce the corporate veil to make Dr Mubanga as majority shareholder and director liable in his own capacity, arguing that he knowingly allowed his company to carry on the

business fraudulently or

wrongly in relation to the

ERB as an institution did not necessarily revoke licences but could suspend if licence fees were not paid.

On Luapula Energy, Dr Mubanga said they had an order with Rubis to supply fuel of approximately two million to four million liters, which he said they failed to supply at the time they brought in the cargo.

He said the product was not for Luapula Energy, but for a company from Dubai, saying when they brought in the product, Rubis refused to get it as the contract had expired, and that was how his company was subcontracted to supply the product.

He said in the midst of supply, the owners of the product called from Dubai stopping Rubis from receiving any product from Luapula Energy as they had an issue with the energy company.

Dr Mubanga said the courts awarded Luapula Energy on the premise that it was a default judgment, claiming his company were not availed an opportunity to give their defence.

In a related matter, the High Court ruled on May 08, 2024 ruled in favour of Luapula Energy Limited against Exxon and Dr Mubanga in his individual capacity over K3.5 million owed to the plaintiff.

Delivering judgment in the matter, High Court Chilombo Bridget Maka ruled that the submission by Luapula Energy held merit and that Dr Mubanga's

For breach of contract we are claiming K6.5 million."

people and we must respect their wishes," President Ramaphosa said at the Electoral Commission's (IEC) **Result Operations Centre** (ROC) in Midrand.

He added that the elections - which took place on Wednesday, 29 May and were preceded by in-country special votes on Monday and Tuesday - have reaffirmed the fact that building a South Africa for all remains the defining mission of the nation.

The President noted that over the course of the election campaign, parties and candidates have at times differed, often forcefully, and expressed a wide variety of

views that are often at odds with each other.

He said throughout the election campaign, parties and candidates have held fast to the fundamental principles of democracy and have affirmed the right of voters to participate in an election that is free, fair, and peaceful.

The President called upon political parties to recognise the results of the election, saying they reflect the will of the people.

"What this election has made plain is that the people of South Africa expect their leaders to work together to meet their needs. They expect the parties for which they

## **Biden officially snubs Zelensky's 'peace** SUMMIT Vice President Kamala Harris and US National Security Advisor Jake Sullivan will go to the conference instead

he Biden administration has confirmed that the US president will not be attending an upcoming summit in Switzerland on the Ukraine conflict, and will send Vice President Kamala Harris and National Security Advisor Jake Sullivan instead.

Media reports suggest Joe Biden will be going to a pre-election fundraiser taking place at the same time as the conference in mid-June.

The Swiss-hosted

gathering is intended to drum up support for Ukrainian leader Vladimir Zelensky's demands regarding the conflict with Russia. Moscow has not been invited, however, while Beijing has declined to participate.

"Vice President Kamala Harris will travel to Lucerne, Switzerland on June 15 to participate in the Summit on Peace in Ukraine," her spokesperson Kirsten Allen said on Monday, adding that this "will underscore the Biden-

Harris Administration's commitment to supporting Ukraine's effort to secure a just and lasting peace."

Allen also confirmed that Sullivan would be joining Harris at the conference, scheduled to take place at the Burgenstock resort.

Biden's travel itinerary had him scheduled to visit Europe later this week, to attend the 80th anniversary of the Normandy landings in France and "part of" the G7 summit, scheduled for June 13-15 in the south of Italy. This had given rise to speculation that he could "stop by" Switzerland or have Zelensky come to him.

Last week, the Ukrainian leader tried to pressure the US president into lending legitimacy to the "peace summit," arguing that his absence would "not be a particularly strong move," and would let down other world leaders who "need President Biden."

Zelensky also claimed that anyone who missed the conference was a tool of Russian President Vladimir Putin.

Monday's announcement, however, appeared to confirm reports that Biden would prioritize a political fundraiser in Hollywood, headlined by actor George Clooney and expected to feature actress Julia Roberts and former President Barack Obama.

Harris, whose 2020 presidential bid fizzled out even before the first primary, became Biden's running mate as part of a deal with the Congressional Black Caucus to endorse the current presidency as a "Biden-Harris" one and tried giving her several important portfolios – from immigration to abortion and voting rights – Harris has mainly been regarded as a gaffe machine on par with her boss.

### **Russian FM Lavrov continues Africa tour in Congo**

ussian Foreign Minister Sergey Lavrov arrived late Monday in Congo on his latest visit to West Africa, where coups and growing discontent with traditional allies like France and the United States have contributed to some countries' shift toward Moscow.

Lavrov was due to meet with Congolese President Denis Sassou N'Guesso in the city of Oyo on Tuesday, according to an official communique from Brazzaville.

The FC 100 is different than most countdowns. It is not a Nos. 1-100 ranking. Rather, we truly take into account all 11 positions on the pitch, whereas most rankers go talent-first with little regard for where the stars play. That leads to uninspiring lists that are heavily weighted toward goal scorers (forwards) and players who create goals from midfield, paying little attention to the talent in less glamorous areas of the field.

Our rankings are divided into four lists and give readers the closest thing to a position-by-position "depth chart" across world soccer.

This year's ballot had over 50 entries from all over the globe and from all areas of ESPN FC; from writers to reporters, from editors to producers, from behindthe-scenes staff to on-air talent. Gab Marcotti, Julien Laurens, Mark Ogden and Alejandro Moreno were just some of the key voters. The biggest change is how we compiled the list. In a nod to the modern game's shift from specialist position players to flexibility and fluidity, we've moved away from the old approach of "10 top 10s across positions and coaches" to a broader list that acknowledges the four key positions on the pitch. Now, you'll see a top 10 of goalkeepers followed

by our top 30 defenders, midfielders and forwards.

The other major update? No more managers! The evolution of the role, from the traditional steward of the whole club to more of a specialist on the team and tactics, means we're focusing on the players here. We will handle our global manager rankings separately later in the summer. This decision has also yielded a lot of new faces in the list this year compared to any previous edition: More than a quarter of the players listed are brand-new to the FC 100 universe in 2023-24, ensuring the list keeps up with the times.

Main takeaways A new format means a lot of new names: This season's edition of the FC 100 has 28 new names for the first time in the rankings' eightyear history, which is a testament to both the evolution of the game and the next generation breaking through in Europe's top leagues. Cristiano Ronaldo is BACK: After dropping out of the FC 100 universe in 2022-23 because of a terrible year in which he had a bitter exit from Manchester United, a poor World Cup and an underwhelming move to the Saudi Pro League, the Portugal star is back on the radar heading into Euro 2024. Behold, an American player! Off the back of a superb season with

AC Milan, United States captain Christian Pulisic returns to the FC 100, making his second appearance. Canada's Alphonso Davies makes his fourth FC 100 appearance following another strong campaign for Bayern Munich.

The Premier League reigns supreme again: In total, 38 members of the FC 100 this year are from the English top flight, with a range of clubs beyond Manchester City, Liverpool and Arsenal contributing to its strength in depth. LaLiga hangs tough in second place with 19 names on the list, though the German Bundesliga has come
