IMF threatens govt with sanctions on Tazama

But Energy permanent secretary Peter Mumba said said the IMF simply reminded the government to open the pipeline to all so that the same could be factored into the structural adjustment programme.

Well placed sources at State House, in the Ministry of Finance and Ministry of Energy have confirmed to Daily Revelation that the IMF has been having a series of meetings with government officials.

Sources said in several meetings, the IMF demanded to know why the TAZAMA pipeline was only being accessed by a selected few companies despite the facility being a public entity. Sources said the IMF questioned why the facility was only being accessed by Mount Meru, Sahara and Vito-Agro, a partnership between Vito and Shashi Patel's Agro-Fuels

"The IMF actually ordered the government to stop the preferential treatment and even threatened sanctions if that were not done," sources said. "As as result the government has yielded and they are now, through the **Energy Regulation Board** (ERB), putting in place new operation guidelines where all the OMCs will have access to the pipeline. You call the government about these new guidelines and challenge them on why they exactly came up with the same. If they are honest they will tell you. They were actually placed on the spot by the IMF."

Daily Revelation contacted and asked Mumba on the guidelines demanded by the IMF and that the same were effected following demands from IMF.

Responding, Mumba acknowledged engagements with IMF.

"First of all let me correct the impression that it's the IMF which demanded. It's government position, from the time government disengaged from procuring of crude, this task now is in the hands of the private sector," he said.

Mumba said in order for the price of fuel to come down, the government was encouraging competition for the Oil Marketing Companies to compete

amongst themselves so that they could have access to the pipeline.

He said among the factors that would be considered for one to have access to the pipeline was the price, including if the OMC's price was below the one recommended ERB.

Further, he said the best among those who would bid would be picked to gain access to the pipeline, stressing that with encouraged competition the country would get to a level where the price of the commodity would start coming down to the benefit of the consumer.

"So IMF simply said 'yes, we support this one.' But because of certain problems that we were facing we couldn't actualise the open access. So that's why the IMF came and said 'government you had promised that this is the way forward, why haven't you actualised this?"' Mumba said. "And they made it to be a benchmark in the structural adjustment programme."

Mumba said the government was now geared to see to it that the pipeline was open to everybody

and that business must be transparent without favouring anybody.

Addressing information that the pipeline was only being accessed by a selected few including Meru, former Nigerian president Olusegun Obasanjo's connected Sahara and oil marketing companies connected to businessman Shashi Patel, Mumba said Vito had partnered with Agro Fuels owned by Patel, namely Vito-Agro, then there was Mount Meru, Sahara, Adax, Ayun, Lio, saying there were about five or six reliable suppliers.

He said the country had experienced a situation where some companies were awarded permits for supply, but for some reasons they have failed to deliver.

"I will give you an example of Standard Petroleum. They gave us a very good price and all of us were very excited. That was in January this year. We have been waiting for them to come forward. Three months ago they just went quiet, they have never come back," Mumba said. "And we are saying, you see if we had put all our eggs in Standard

Petroleum where would we be as a country in terms of fuel?"

He said Standard was not the only company that had disappointed the government, as they were a few more, to the point where the government only remained with the same reliable ones, namely Agro, Mount Meru, Addax, which he said had gone into partnership with Suban of Ndola, among others to supply through the pipeline.

On the shortages of fuel experienced in the recent past, Mumba said the "sporadic shortages here and there for diesel", was on account of the fact that the current pipeline capacity visa-vis the demand could only supply at 80 percent.

He said it could not be forced to go beyond that limit, and that 20 percent was left to the OMCs to supply by road.

He said the administration had gone into an agreement with those who were bringing in the fuel by road to meet their transportation costs halfway.

"So we pay them according to the distances they have covered etc,"

Mumba said.

He said the government was doing the same for petrol transportation that was delivered 100 percent by road, but could not tell how much was involved as it was just a formula they had come up with.

He said on account of loadshedding, the demand for diesel had gone up so much to the point where at Ndola Energy for instance, which used to use HA4 oil when Indeni Refinery was in operation, but after its demise, the company reconfigured their plant to diesel to fire up the plant.

He said the same was consuming 20 million liters from the pipeline every month, hence reducing the diesel going on the market.

He further said Gensets were being used everywhere now, including at Filling Stations as a result they were consuming a lot of diesel, including the mines which he said were major consumers of diesel.

"So that's why you are seeing a few things falling not into place. But we are addressing that as government," said Mumba.

The Kitwe High Court stayed EuroAfrica Kalengwa Mines Limited's Large Scale Exploration License number 8584- HQ-LEL while Kalengwa Mineral Processing Limited (KMP) had applied to have Moxico Director Allan Davies cited for contempt of court over resumption of operations at Kalengwa mine despite a ruling that halted the works.

But in an interview yesterday, Kabeta said Kalengwa Mineral Processing Limited had given the government a go ahead to launch Kalengwa Mine by President Hakainde Hichilema because they realised they made a mistake by suing the President.

"No l think it is irregular. You don't do such things to the Head of State. A Head of State cannot be prevented from doing his job. So when the President makes a decision that he wants to do this, if they have any legal claims on it, they can sue the other people who can be sued," Kabeta said. "But not and never the President of the Republic of Zambia. That is the provision of the law that he cannot be sued by anybody. I think, there was a realisation that it was a mistake. That is how they came forward to say they had no objections."

When asked if Kalengwa Mineral Processing would not continue with contempt

of court proceedings against directors of Mexico resources Zambia Limited and Euro Africa Kalengwa Mine Limited together with the ministry of Mines, Kabeta said that could not happen since the mining company had given them a green light to proceed with the launch of the mine

"No! No!No! That writ of contempt of court they have lost because they have authorised the mine to open and they have done that through their lawyers, so there is nothing contemptuous about that," Kabeta said.

He however, said Kalengwa Mineral Processing Limited had a right to proceed with the court process.

He added that if the company proved to the court, they would be given what

claims, they will need the courts to help them justify their claims," Kabeta said.

"So if they can convince the courts, they will get what is due to them, but if they fail to convince the court, they will not get what is due to them. Yes! That is judgment and we shall respect it in whichever form it takes."

By Chinoyi Chipulu dola Pastor's Fellowship Association chairperson Reverend Chilekwa Mulenga says the Church should help to reconcile former president Edgar Lungu and President Hakainde Hichilema, instead of politicking while using the Bible.

And Life Gospel Fellowship Ministries Church International Overseer Bishop Joseph Kazhila has stated that his sermon was deliberately twisted to incite hatred and resentment against him.

But Rev Mulenga said Bishop Kazhila should have been guided on the need to promote love and unity as he preached during the prayer and fasting.

Last Friday, during the National Day of Prayer Fasting and Reconciliation where President Hakainde Hichilema was officiating in Kitwe, Bishop Kazhila said every throne must be consecrated because some people reaped what they did not sow.

In his sermon, Bishop Kazhila said whenever there was a change of government, the Church should be invited to the State House to pray for the throne.

"David a man after God's heart has become a king of Israel and the Bible says for three consecutive years, there was famine, the first year perhaps someone will say it is just climate change, the second year someone will be saying El Nino, but when it came to the third year, David realised

that I'm a man after God's heart, how can this God who put me on the throne allow this famine to come in the land and when he went to God he was told that you are not the cause of the problems, you inherited these problems," he said.

He said people should not be blaming the government for the things they should be owning up to themselves.

"This is where we have been missing it. We hear when former president Fredrick Chiluba declared Zambia as a Christian nation, some people went to State House to consecrate it. But this is what should have been done at every change of government, there should have been the Church going to State House to go and pray and declare the presence of the Lord on the Land, we have not done so. Our Church mother bodies where you are?" he asked

But Rev Mulenga said the clergy should stick to preaching the gospel and theologically sound messages for the salvation of souls.

"The idea to put Ba Kazhilla on the program to preach such a conflicted sermon, who is well known to be aligned and questionable, was the plan of the establishment he belongs to. Ba Kazhilla is not a leader of any Church mother body, not even a Pastors fellowship, who approved him to preach?" Rev Mulenga asked.

"We should have spared our dear brother Ba Kazhilla from such homiletically off the key homily. Ba Kazhila's gifting was highly misplaced." Rev Mulenga said the

Bible. "Let's be very careful and measure our sermons well. To politically aligned clerics, be reminded that no political party stays in government forever. Where is the PF today? Don't be used by politicians instead, be there to guide them. The Body of Christ is forever, let's keep

Rev Mulenga also said the clergy should maintain the prophetic role of the Church and remain focused on the word of God.

Bishop Kazhila who received mixed reaction from social media platforms after the sermon he delivered at the event, released a statement to

Two girls narrated how they were defiled by man, 61

By Esther Chisola wo girls aged 11 and 12, have narrated before Lusaka Magistrate Mutinta Mwenya how a 61 year-old security guard threatened to kill them if they screamed for help while he was defiling them at his single roomed house.

The victims were testifying in a matter in which Binwell Mwansa 61, is facing two counts of defilement of a child contrary to the laws of Zambia.

Allegations are that Mwansa on dates unknown but between April 1, 2024 and April 26, 2024 in Lusaka had unlawful carnal knowledge of the girls under the age of 16 years.

When the matter came up for trial, one of the girls narrated to magistrate Mwenya how the accused gave them a K10 to share after defiling them. She said she was coming from school when she met Mwansa who asked her to go to his house with her friend.

"We went to his house and left our shoes outside. He told me to undress and had carnal knowledge with me. My friend was sitting down in the sitting room. He gave us a K10 to share. He peeped outside if people were coming and upon noticing there was no one he asked us to leave," she narrated.

The girl said she later told the sister who reported the matter to Chilanga police where they were referred to UTH (University Teaching Hospital).

She said the defilement happened on April 26 at the suspect's one roomed house. The girl said the incident

happened four times since last year.

"We used to go to his house to clean and wash plates. I felt pain. He used to be our neighbour. He threatened to kill me," she said.

During cross-

examination, the victim was asked if the accused asked them to enter his house, one of them responded saying, "yes you told us to sit down after we finished cleaning."

Further asked if they did have carnal knowledge with the accused in his house, the girl responded in the affirmative.

The other victim also narrated how she was defiled and how she saw her friend being defiled.

"He called me to his house to clean and made me sleep in his room, removed his manhood and had sex with me. I felt pain. After some days my friend came to pick me up and asked me to escort her to Mwansa's house and I accompanied her," she narrated.

The girls said Mwansa

welcomed them to his house that was why they also cleaned the house and he gave them some drinks.

She said the suspect had sex with her friend whilst she was in the living room.

"I peeped in the room and saw him having sex with my friend. I had white discharge coming out from my vagina the time he had sex with me, it was very painful," she narrated.

In cross-examination, the victim was asked why she did not shout so that the accused landlord sitting in the corridor could hear, she responded saying, "you stopped us and threatened us".

Further asked how he threatened them, she responded saying, "you told us you would kill us and wouldn't eat your things".

The matter comes up on November 13, 2024 for continued trial.

(ZWW) spokesperson Muhabi Lungu says lies have started catching up with President Hakainde Hichilema regarding the issue of loadshedding, which he attributed to poor management by PF when he was in opposition.

During the National Day of Prayer, Fasting and Reconciliation last week, President Hichilema said loadshedding was a historical problem and that the country was paying for failing to invest in the energy sector 20, 30 years ago.

By Jane Chanda conomist Dr John Musantu says the government's projected 6.6 percent Gross Domestic Product (GDP) growth rate in the 2025 national budget is unrealistic and overly ambitious.

Dr Musantu this after considering Zambia's current economic challenges in response to the International Monetary Fund's (IMF) revised growth projections, which downsised Zambia's 2025 growth from 2.3 percent to 1.2 percent of GDP, which was previously from 4.7 percent to 2.3 percent in June.

In an interview with Daily Revelation yesterday, Dr. Musantu said the IMF's downward revision of growth projections from 2.3 percent to 1.2 percent served as a reality check for Zambia's economy, saying the country needed to stabilise its economy in 2025 by focusing on energy and copper production before expecting significant growth in 2026.

He said the mining sector had the potential to drive growth, but cautioned that the IMF's projections may discourage investors and reduce foreign direct investment.

Dr Musantu talked about the cost of living and the significant impact of fooddriven inflation and drought on agricultural production.

He also talked about

the need for conservative inflation projections given the time required to revitalise agricultural output.

Dr Musantu further expressed optimism regarding the government's initiatives to promote irrigation and reduce solar product costs, which could help control food prices and inflation.

The economist noted the importance of realistic targets in light of the IMF's revised projections, noting that Zambia's economic growth was expected to remain sluggish in 2025.

He said country needed to acknowledge its economic situation and plan accordingly, adding that it was better to start with conservative numbers rather than chase unattainable goals.

Dr. Musantu expressed concerns over Zambia's 6.6 percent growth target, saying there was need for prudent economic management to address the country's structural challenges.

He said the government must acknowledge the economic realities and plan accordingly, rather than setting unrealistic goals, which overlook critical issues such as poverty, unemployment, and reliance on copper exports.

According to Dr. Musantu, Zambia's economic recovery was contingent upon

addressing its energy deficit, diversifying its economy, and attracting investment.

He said that Zambia's path to economic recovery hinged on strategic stabilisation and leveraging key sectors.

Dr Musantu said the approach was crucial in addressing the country's structural challenges and capitalizing on opportunities for sustainable growth. Meanwhile, According to the IMF, Zambia's economic recovery faces challenges amidst drought and power outages.

An IMF mission to Zambia has revealed significant challenges to the country's economic recovery.

During the mission, IMF mission chief Mercedes Vera Martin and her team met with high-ranking Zambian officials, including President Hakainde Hichilema, Minister of Finance and

According to the statement, the team also engaged with representatives from the private sector and development partners.

In statement on October 17, Martin stated that Zambia's economy had been severely impacted by prolonged power outages, particularly in the nonmining sector, which has hindered growth.

Martin stated that Zambia's growth projections

By Chinoyi Chipulu SCO Linned says the company has lost 150 Megawatts of power due to a technical fault at Maamba Energy Limited (MEL). In a statement yesterday, Zesco spokesperson Matongo Maumbi stated that MEL was working diligently to complete the corrective maintenance and restore normal generation as soon as possible. Maumbi stated that the fault would be repaired within a week. "Due to an unforeseen technical fault, MEL, an Independent Power Producer (IPP), has had

to undertake corrective maintenance on one of its two generators. This has resulted in the temporary reduction of the available national power generation by 150 Megawatts," he stated. Maumbi stated that the utility company would strive to maintain the three-hour supply schedule in residential areas during this time of a significant power supply shortfall by optimising the power imports in collaboration with some Power traders and ramping up availability from the other Independent Power Producers, where possible.

"The maintenance is expected to last from October 20 to 27, 2024, reducing the available power generation capacity during this period MEL is working diligently to complete the corrective maintenance and restore normal generation as soon as possible. ZESCO is collaborating closely with all partners to minimise disruptions and ensure a timely return to normal operations," he stated. Zesco has since appealed to all of its valued customers to continue practicing energy efficiency during this period.

Leaked documents show US intelligence on Israel's plans to attack Iran, sources say

The US is investigating a leak of highly classified US intelligence about Israel's plans for retaliation against Iran, according to three people familiar with the matter. One of the people familiar confirmed the documents' authenticity.

The leak is "deeply concerning," a US official told CNN.

The documents, dated October 15 and 16, began circulating online Friday after being posted on

Telegram by an account called "Middle East Spectator."

They are marked top secret and have markings indicating they are meant to be seen only by the US and its "Five Eyes" allies — Australia, Canada, New Zealand and the United Kingdom.

They describe preparations Israel appears to be making for a strike against Iran. One of the

documents, which says it was compiled by the National Geospatial-Intelligence Agency, says the plans involve Israel moving munitions around.

Another document says it is sourced to the National Security Agency and outlines Israeli air force exercises involving air-to-surface missiles, also believed to be in preparation for a strike on Iran. CNN is not quoting directly from or showing the documents.

A US official said the investigation is examining who had access to the alleged Pentagon document. Any such leak would automatically trigger an investigation by the FBI alongside the Pentagon

The foreign minister did not mention Washington directly in his message, but his post included a link to an article by Reuters, on Biden confirming that he is aware of Israeli plans to target Iran. RT

Norris takes US pole with 'best lap of

my career'

cLaren's Lando Norris beat title rival Max Verstappen's Red Bull to pole position at the United States Grand Prix with what he said was "the best lap of my career".

Norris was helped by Mercedes driver George Russell crashing late in the session, which prevented any driver improving on their second laps.

Norris had been 0.031 seconds quicker than Verstappen on their first laps, but the Dutchman had started his final lap much better than the Briton, only for both to have to abort.

Although luck played its part, the result was just what Norris needed after Verstappen won the sprint race earlier in the day.

With Norris finishing third behind Ferrari's Carlos Sainz, Verstappen extended his championship lead by two points to 54.

That made Norris' task in the championship even tougher - he needed to take an average of nearly nine points per race out of Verstappen for the remaining six grands prix of the season to beat him to the title.

By taking pole position, Norris has given himself an opportunity to claw back some of that gap in the grand prix, although Verstappen's pace has looked formidable all weekend after Red Bull introduced some upgrades on to their car. McLaren had been struggling in comparison but Norris excelled himself to go fastest on the first runs before Russell's accident confirmed his pole.

"It was a beautiful lap," Norris said. "I was not going to go much quicker than I did.

"When you just do a lap and you think it's going to be tough to beat... I put everything on the line, I needed to do it.

"We've not had the pace of the Ferraris or Red Bulls so I had to do something, and I did that.

"It was a very good lap. I can probably say quite confidently the best of my career."

Both Norris and Verstappen made mistakes at Turn 19 on their first laps. Norris had a slide, forcing him to catch the rear, while Verstappen had to lift after missing the apex.



Max Verstappen (left) was the fastest driver in Q1 and Q2 but Norris took pole

Verstappen was then 0.2secs quicker than Norris in the first sector on their second runs - and Norris was slower there than on his first run - before they both had to abort.

Verstappen said: "On the first lap in Q3 I lost quite a bit of time there. I knew we had another run but unfortunately I couldn't finish the lap, but that's how it goes. At least the potential was there to be first, so that's very good."

McLaren's Oscar Piastri took fifth, 0.620secs slower than Norris, while Russell was still sixth despite his crash.

For team-mate Lewis Hamilton it was a terrible day. The seven-time champion qualified 19th, Mercedes saying he had "messy balance and front locking".

aul Kagame, president of Rwanda, may govern a small, landlocked nation in central Africa, but his ambitions are large.

Recently, he embarked on a significant mission: bringing a Formula 1 Grand Prix to Rwanda.

This effort reflects his broader strategy of positioning the country, once devastated by genocide, as a continental leader in Africa. Despite Rwanda's geographic limitations, Kagame has consistently pursued political, diplomatic, and economic plans to boost the nation's prominence. further supports Rwanda's bid to enter the global sports arena, including the possibility of hosting a Formula 1 Grand Prix. Formula 1 Talks and

Economic Challenges Rwanda is in discussions with Formula 1 executives about hosting a race, a move that could cost billions of dollars. Though the idea of a Rwandan Grand Prix may seem far-fetched due to the lack of infrastructure and the country's modest \$14.1 billion GDP, it is not impossible.

F1's CEO Stefano Domenicali described Rwanda's proposal as serious. Rwanda's bid could gain momentum when it hosts the FIA's annual general assembly in December, further enhancing the country's motorsport profile. Kagame is following the path of Gulf countries like Qatar and Saudi Arabia, using sports to boost Rwanda's international reputation, although this strategy has sparked criticism. Some accuse Rwanda of using sports to distract from its human rights record, a practice often referred to as "sportswashing."

Human Rights Concerns and Criticism

Despite the potential benefits of sports diplomacy, Rwanda's reputation is tainted by its human rights record. Kagame, who won 99.2% of the vote in the last ylian Mbappé is not affected by the media turmoil around a potential rape allegation, his coach Carlo Ancelotti said

Kylian Mbappé will be back in the public eye when Real Madrid return to La Liga action at Celta Vigo on Saturday.

Mbappe injured his left thigh in late September. But he missed only one game for Madrid, returning as a substitute in a shock 1-0 defeat to Lille in the Champions League.


